Summary of my Activities and Future Plans

My research interests center the aspects of policy and ethics in the health and medical fields. It is important for me to integrate research with public influence.

I am currently working on several research projects:

- * My postdoctoral research focuses on issues in reproductive ethics, with an emphasis on public funding of Assisted Reproductive Technologies and the concept of the right to procreate re-Israeli policy and the context of fertility treatments in Israel.
- * Another study deals with using Big Data in fertility technologies in an attempt to improve fertilization treatment results.
- * An additional study centers on tracing citizens by the government during the covid-19 pandemic in Israel. This study is carried out jointly with Dr. Shiran Bord and Dr. Carmit Satran.
- * During 2020, I began working with a hospital Intensive Care Unit based on an ethical advisory model I developed together with Dr .Gila Yakov. The work will be accompanied by an evaluation study.
