L. Summary of my Activities and Future Plans

Since receiving my current academic rank, I established a leading international role in the study of psychological correlates of cannabis use and cannabis use disorder. Scholarly projects which I initiated and led have made a notable impact on the field of cannabis research, including authorship of 22 papers in peer-reviewed journals (49 papers in total), leading an official report for the E.U's authority on drug monitoring, editing a

special issue and most recently, developing and validating a standardized instrument for clinical and academic assessment in the field of cannabis use. Since receiving my current rank, I took a senior role in several research projects, empowering research students and young researchers to serve as first authors while closely mentoring them and serving as project manager. This move has allowed me to keep an active and fruitful lab and mentor the future generation of researchers while engage in additional academic projects which will be described hereby.

In 2020, I was a guest editor in a special issue titled 'Psychological aspects of cannabis use and cannabis use disorder', published in *Frontiers in Psychiatry: Addictive Disorders* (IF 2.857). This special issue included 14 published manuscripts, with contributions from leading researchers in the field, which were now downloaded more than 80,000 times. Following this contribution, I was invited by the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA) to serve as a co-PI in the preparation of an official report on cannabis use disorder treatment efficacy and availability in the E.U. My involvement included building an international team of contributors, as well as coordinating the ongoing academic work and keeping routine contact with the EMCDDA administration. This report has been recently submitted to the EMCDDA and I presented it in an invited lecture at 'Lisbon Addictions 2022', the most impactful European conference on addictions. Three manuscripts based on the report are currently in final stages of preparation prior to submission to a special issue dedicated to the report in *European Archives of Psychiatry and Clinical Neuroscience* (IF 5.76).

Furthermore, following a commentary I published in *Lancet Psychiatry* (IF 18.329), I recently led a multidisciplinary team of research experts in the fields of psychology, medicine and public health in developing the Medicinal Cannabis Consequences Scale (MCCS), an assessment tool for identifying problematic use of medicinal cannabis. This highly anticipated tool has been validated throughout (see, for example, Gliksberg et al., accepted; Hulaihel et al., 2022) is currently being submitted to publication and assimilated into treatment centers in Israel.

My research lab has continued to be extensively active and fruitful since receiving my current academic rank. Since 2020, I was the author of 22 papers published in peer-review journals, seven of which were published in Q1 journals, and two book chapters. Of these total 24 publications, I was the first author in 10 papers and two book chapters and the senior (last) author in seven papers, five of which were first-authored by research students from my lab (working under my supervision). My recent authored papers were

published in leading journals, including *Lancet Psychiatry* (IF 18.329), *Schizophrenia Bulletin* (IF 7.575), *CNS & Neurological Disorders Drug Targets* (IF 4.388) *International Journal of Drug Policy* (IF 4.244), *Schizophrenia Research* (IF 3.958), *Drug and Alcohol Dependence* ISI (IF 3.951) and *Addictive Behaviors* (IF 3.91).

Five of my last 22 publications in peer-reviewed journals were international collaborations which stem from my increasing involvement in the global cannabis scientific community. For example, following my participation in the Lisbon Addictions 2019 workshop on 'Standard Cannabis Joint' I collaborated with top cannabis researchers, led by Prof. Antoni Gual from the Hospital Clínic de Barcelona, Barcelona, Spain, in writing two conceptual papers which were published to addiction journals (see López-Pelayo, 2021a; López-Pelayo, 2021b). In addition, following my invited contribution to a book on Cannabinoids and Neuro-Psychiatric Disorders published by Springer Publishing (see Feingold & Weinstein, 2021), I was invited by the co-editor, Prof. Eric Murillo-Rodríguez from the Anahuac Mayab University in Mérida-México, to contribute to an international collaborative review focusing on neural correlates of the association between cannabis and depression (see Alcaraz-Silva et al., 2022). An additional review by this team is currently in preparation.

My future plans involve primarily a four-year multi-method longitudinal investigation of the effect of heavy cannabis use on romantic relationships. This project recently received the Israeli Science Foundation (ISF) grant (personal track) for four years, 360K NIS. It is expected to broaden our understanding of the psycho-social effects of heavy cannabis use and inform policy makers concerning its harms/benefits. This is important considering the recent advancement towards legalization of cannabis in Israel and abroad. In addition, I expect this project to excel my lab's effort to develop the means required for conducting multi-method studies focusing on lives and subjective experiences of individuals who use drugs, particularly in the field of intimate romantic relationships. Another international collaboration which has recently undergone is a longitudinal multisite study on the effect of cannabis use on psychological treatment outcome. This project is a collaboration with Dr. Carrie Cuttler from the Department of Psychology at Washington State University, U.S.A, Dr. Walter Scott, Director of Psychology Clinic, Washington State University Department of Psychology, U.S.A., and Prof. Garry Diamond, Director of Community Clinic at the Department of Psychology, Ben-Gurion University. The project is expected to launch in 2024.

In addition to the international impact made by my work, I continue to work on a national level to enhance the field of addiction research and evidence-based practice. I am considered an Israeli expert in addiction research and practice, serving as a board member at the Israeli Society on Addiction Medicine (ILSAM) and a consultant to the head of the Rehabilitation unit in the National Psychological Union. Under these two positions, I recently participated in writing several invited white papers concerning upcoming legislative changes in the field of substance use I Israel: cannabis legalization and transferring the drug rehabilitation services from the ministry of health to the Heath Service Organizations. As a follow-up to one of these documents, I also represented the Rehabilitation unit in the National Psychological Union in a parliament ('Kneset') meeting of the joint committee examining the transfer of drug rehabilitation services to the Heath Service Organizations.

Along these public service efforts, I continue my mission to share and assimilate the knowledge on addiction research and practice through my positions as guest lecturer in various professional training programs and thorough invited lectures in scientific conferences, student counseling services, and other academic and clinical forums across Israel and abroad.
