K. Summary of Activities and Future Plans

After 5 years of Post-Doctoral research in the universities of Glasgow and Edinburgh in Scotland, I joined the Department of Behavioral Sciences in Ruppin Academic Centre, and set up the <u>Linguistic Cognition Lab</u>. In the studies conducted in my lab I explore the interactions between language and different psychological processes, aiming to understand how these interactions affect behavior. My studies focus on 3 main topics:

Inner speech and Prosody. Fascinated by the prosodic aspects of language (e.g., rhythm intonation, stress), I investigate the different ways in which prosody is involved in the representation of linguistic structures, thoughts (inner speech), emotions and communication. I am currently exploring the idea that prosody can serve as a window to embodied linguistics. The aim of this project is to examine evidence for implicit prosody (prosody of silent-inner speech), and shed light on its role in representing emotional, pragmatic, and syntactic aspects of language, and its contribution to linguistic prediction. I pursue this line of research (supported by an ISF grant) in collaboration with Prof. Zohar Eviatar, and M.A. and Ph.D. students from Haifa university and from Ruppin Academic center.

A different direction on my investigation of inner speech evolved from my collaboration with colleagues in the M.A. program in clinical psychology, focusing on the role of prosody and inner speech in psychological processes. I collaborate with Prof. Yossi Levi-Belz on studies that aim to use acoustic analysis of speech prosody as a tool for evaluating psychological processes related to anxiety, mental pain and self-disclosure. I further collaborate with Prof. Ada Zohar on a line of studies that explore the contribution of inner speech to psychological coping with state-anxiety and ADHD. To this end, we translated, adapted, and validated a Hebrew version of an inner-speech self-report questionnaire (VISQ-R, Alderson-Day, Mitrenga, Wilkinson, McCarthy-Jones & Fernyhough, 2018).

Bilingualism. Having returned from the post-doc to the multi-lingual society in Israel, in the last few years I developed interest in bi- and multi-lingualism. I focused on the interaction between long-term language experience and brief recent experience on the performance of bilingual speakers in the different languages they speak. In this line of studies (supported by a 4-years ISF grant 2014-2018) I collaborated with Dr. Tamar Degani in examining how different linguistic tasks (e.g., comprehension, production) in one language affect subsequent performance in the other language. To examine the effects of long-term experience we examined how such language shifts affect different bilingual populations (minorities, immigrants, heritage speakers) that differ in their language experience in terms of age of acquisition, switching habits, proficiency etc.. So far, I have studied these processes in children and adults, in the future I plan to extend this line of research to the elderly, and examine life-long changes in the factors that modulate bilingual performance.

Biases in Judgment and decision making (JDM). Aiming to understand how language is involved in biases in judgment and decision making my studies on this line of research focus on the Attribute Framing Bias. My studies in collaboration with Prof. Eyal Gamliel have examined how the way we use words to frame information generates biases in evaluations,

and how cognitive processes related to memory and attention interact with language in modulating these biases. My studies thus far relied on self-report questioners, in my future studies I aim to use objective on-line behavioural measures including priming and eyemovements to shed more light on the ways JDM biases are modulated by the interaction of cognitive and psycholinguistic processes.

In general, my future research will continue these different lines of research aiming to gain a comprehensive insight on the role of language in mental representation, in thinking and decision making, and in socio-emotional processes.
