Special Activities

A The Sheshinski (2017-2018) Pension Committee

The purpose of the Sheshinski Committee was to propose a solution to the problem of the elderly without a pension or those with a low pension, in the interim period (until 2045) until the effect of the mandatory pension is felt to a sufficient extent. In my role as the committee's scientific coordinator, I drafted the model presented in the conclusions and mainly built the simulations used to present the results. The committee's conclusions were subsequently adopted by a special committee of the Knesset (2020).

B The Joint applied research grant (2021)

The goal of the *Joint* research grant was applied research for the Prime Minister's Office regarding an advanced model for employing nannies for nursing elderly people. The model included the construction of complex financial and health alternatives and the analysis of the actual costs. The conclusions of the project were approved by the office of the Prime Minister and the Treasury and in November 2021 the project proposed pilot was included in the state's budget for 2022.
